***Who is a Commissioner for Declarations?**

A person over 21 years of age and under 70 years of age and a member of designated professions or employment groups is automatically an ex officio Commissioner for Declarations.

Some *designated professions* are dentist; legal practitioner; medical practitioner; nurse; pharmacist; veterinary surgeon.

Some *designated employment groups* are bank, building society or credit union officer with 5 or more years of continuous service; civil marriage celebrant; clerk of a court; member of the Institute of Chartered Accountants in Australia, the Australian Society of Certified Practising Accountants or the National Institute of Accountants; member of the Institute of Corporate Managers, Secretaries and Administrators; member of the Parliament of the Commonwealth or the Parliament of a State legislature or a local government authority of a State; permanent employee of the Commonwealth or of a Commonwealth authority or a State or of a State authority or a local government authority with 5 or more years of continuous service; permanent employee of the Australian Postal Corporation with 5 or more years of service who is employed in an office supplying postal services to the public; teacher employed on a full-time basis at a school or tertiary education institution.
